

BOYS' HIGH SCHOOL ATHLETICS PARTICIPATION OPPORTUNITIES "AT RISK" OF BEING ELIMINATED IF THE PROPORTIONALITY QUOTA OF THE THREE-PART TEST IS APPLIED TO HIGH SCHOOL SPORTS, AS ADVOCATED BY THE NATIONAL WOMEN'S LAW CENTER IN THEIR COMPLAINTS FILED WITH THE OCR

The "boys opportunities at risk" of being eliminated calculations assume that these districts and high schools are unable to add additional girl participants to their athletic programs, either due to the fact that they already offer all sanctioned girls' sports in their state, they do not have funding to underwrite new programs or lack of interest among girls not now participating in their athletic programs. To the extent that these schools and districts could add girl participants, the number of boys' opportunities at risk would decrease.)
Chicago Public Schools (IL)	Up to 6,445	Hyde Park Academy School	Up to 110 of 150	73.3 %	This is a magnet school offering the IB program in the Hyde Park section of Chicago, home of the University of Chicago. It appears that they offer 6 girls' and 7 or 8 boys' sports. The percentage of boys that they would need to cut if they could not add significantly to their girls' participation numbers is staggering. The current Secretary of Education, Arnie Duncan, was the CEO of the Chicago Public Schools for seven years prior to his appointment by President Obama in 2008.
Sioux Falls School District (SD)	Up to 550	Washington High School	Up to 228 of 405	56.3 %	
Oldham County Schools (KY)	Up to 195	Oldham County High School	Up to 74 of 135	54.8 %	This school in northern Kentucky (near Louisville) appears to offer all KHSAA sanctioned boys' and girls' sports (9 girls' sports and 10 boys' sports, including swimming). As a result, they do not have the ability to increase the number of girl athletes by adding sports. Accordingly, they might have to cut over half of the boys now participating in sports unless their coaches could recruit a significant number of additional girls to join their existing teams. Assuming that they elected to keep their football and boys' basketball teams, Oldham County High would likely need to eliminate all of their other 8 boys' sports teams to achieve proportionality (baseball, cross country,

					golf, soccer, swimming, tennis, track and wrestling).
Henry County Schools (GA)	Up to 400	Stockbridge High School	Up to 124 of 170	72.9 %	This suburban Atlanta school offers 8 girls' sports and 9 boys' sports. They appear to not offer four GHSA sanctioned girls' sports: gymnastics (a sport offered by very few schools in Georgia), lacrosse (an emerging sport in Georgia), riflery and swimming (presumably they do not have a pool, which is the case for the vast majority of high schools in Georgia.). Assuming that the school added girls' teams for gymnastics, lacrosse and riflery and thereby added 45 additional girls to their athletic program, they would likely still need to cut 80 of the 170 boys' opportunities to become proportional.
Houston Independent School District(TX)	Up to 2,500	Sterling High School	Up to 139 of 245	56.7 %	
Wake County Public School System (NC)	Up to 2,650	Middle Creek High School	Up to 157 of 280	56.1 %	This Raleigh area school offers 11 girls' and 12 boys' sports teams, which includes all of the NCHSAA sanctioned girls' sports, including indoor track (which the school website indicates is not funded, but they list that they have coaches for the team). Like Oldham County High noted above, they therefore have very limited options to increase girls' participation and would likely have to make massive cuts to the boys programs to get proportional (likely eliminating the majority of their boys' teams assuming that they retained football).
Irvine Unified School District (CA)	Up to 800	Woodridge High School	Up to 211 of 610	34.6 %	This Orange County, California school offers 12 girls' sports, including water polo and lacrosse, and 13 boys' sports. This school has excellent athletic program participation rates for both boys and girls athletics (610 of 1155 boys and 355 of 1030 girls), which would likely make it difficult to realize significant gains by recruiting more girls to play.
Columbus City Schools (OH)	Up to 1,070	Brookhaven High School	Up to 139 of 260	53.5 %	
Deer Valley Unified School District (AZ)	Up to 760	Deer Valley High School	Up to 207 of 470	44.0 %	This school on the west side of Phoenix offers 9 girls' sports and 11 boys' sports, which appears to be all the Arizona Interscholastic Association girls' sports other than badminton. If adding a badminton team added 15 girls, they would still need to cut over 190 boys.
Clark County School District (NV)	Up to 3,790	Coronado High School	Up to 235 of 545	43.1 %	This Las Vegas area school has 10 girls' sports and 11 boys' sports, which appears to be all the Nevada Interscholastic Activities Association girls' sports other than skiing.
Worcester Public Schools (MA)	Up to 660	North High School	Up to 125 of 230	54.3 %	This school offers 8 girls' and 8 boys' sports.
